

Aunite.io Privacy Policy

The present privacy policy (further referred to as Policy) shall apply in regards to all information collected about a user by aunite.io. The user's agreement to provide personal data under the present Policy as the part of his relations with one of the parties visiting this website shall apply to all parties.

Using the website shall mean unconditional consent of a user with the present Policy as well as the terms herein concerning processing his personal data; in the event that a person disagrees with the present terms they should abstain from using the Service.

1. Personal data of users collected and processed by aunite.io

1.1. The present Policy understands "user's personal data" as follows:

1.1.1. The personal data provided by a user on his own when filling in the feedback forms, including his personal data. The information which is mandatory for rendering Service has a special mark. Other details are provided by a user on his own discretion.

1.1.2. The data which is automatically transferred during the process of using Service with the help of the software installed on the user's device, such as an IP address, cookie data, the information about the user's browser (or any other program used by them to access Service), access time and URL of the requested page. Processing of personal data means any operation or set of operations which is performed upon Personal Data, whether or not by automatic means, such as collection, recording, organization, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, blocking, erasure or destruction.

1.2. The present Policy is solely applied to aunite.io. The website does not control and is not responsible for third party websites, which a user may visit via the links available on aunite.io, including the search results. Such websites can collect or request other personal data of a user as well as to perform an operation in regards to a user.

1.3. The website generally does not verify authenticity of the personal data provided by users as well as their legal capacity. However, the website is based on the fact that a user provides credible and sufficient personal data on the items contained in the registration form as well as the fact they maintain relevancy of these details.

1.4. The Company's employees who have access to Users' personal data have read the present Policy as well as the Company's internal regulations on the safety of the personal data.

2. Purposes of collection and processing of personal data

2.1. The website collects and retains your information only necessary to provide and render services (execution of agreements and contracts with a user).

2.2. The website may use your personal data with the following purposes:

2.2.1. Identify a party within the frames of agreements concluded by aunite.io;

2.2.2. Provide a user with personalized services;

2.2.3. Contact a user, which includes sending notifications, requests and the information concerning using of Service, providing services as well as processing users' requests and instructions.

2.2.4. Improve quality and enhance comfort of services as well as development of service;

2.2.5. Target commercial campaigns;

2.2.6. Conduct statistical and other types of researches, using the anonymized data.

3. The terms of processing of user's personal data and transferring the data to third-party companies

3.1. The website saves users' personal data in compliance with the internal regulations of certain services.

3.2. Confidentiality applies to the user's personal data with the exception of cases when a user provides their personal information to the unlimited number of third parties on his own. When using some services, a user agrees that a certain part of their personal data becomes available. Upon that, aunite.io shall not be liable for the third-party actions in regards to the information that a user makes publicly available. A user shall be solely liable

for all the risks associated with such exposure, including the risks of availability of these details to fraudsters and spammers.

3.3. In the following cases, the website has a right to transfer the user's personal data to third parties:

3.3.1. The user has expressed his consent with such actions;

3.3.2. This transfer is part of using a certain Service or provision services to a user;

3.3.3. This transfer is to comply with the Russian or other country's applicable legislation as a part of the regulation legally provided;

3.3.4. This transfer is the part of sale or other type of business handover (fully or in part) with a transferee receiving all liabilities to comply with the terms of the present Policy applied to the collected personal data.

3.3.5. On the event a user violates the User Agreement with aunite.io services, this transfer is to ensure the possibility of protection of legal interests of aunite.io or third parties.

3.4. While processing personal data, aunite.io is based on the Russian Law "On Personal Information".

4. The change of personal data by a user

4.1. At any time, user can change (update, add) the personal data provided by him, or its part as well as its privacy parameters.

5. Aunite.io website takes sufficient technical and organizational measures in order to protect personal data of aunite.io website users from unauthorized or accidental access, removal, editing, blocking, copying, spreading as well as other unauthorized actions by third parties.

6. Change of the Privacy Policy. Applicable law.

6.1. Aunite.io has the right to adjust the present Privacy policy. Upon that, the data of the most recent modification is specified herein. The new version of the Policy shall take effect from the publishing date if the new version does not stipulate otherwise.

6.2. The Russian legislation is applicable towards the present policy, as well as to the relationship between a User and aunite.io, rising in regards to the application of the present Privacy policy.

6.3. If you continue using the present Policy after the adjustments were made you thereby agree to these adjustments.

7. Protection of personal data and Cookies

7.1. Aunite.io collects and processes the data solely received via filling in the registration forms and the relevant fields of the aunite.io client area, as well as the data received in response to the query and participation in the affiliate network of aunite.io.

7.2. Aunite.io agrees to abide by all laws, regulations, policies and provisions on privacy as applied to the regions where service is provided.

7.3. Aunite.io shall comply with all applicable laws, including GDPR and EU laws on privacy as well as to take the following measures:

- informing end users on the application of tracking technologies used in the advertising purposes;
- asking for the consent of end users with placing cookie files as well as tracking technologies on their devices and providing the information about the possibility to refuse from this or removing cookie files if necessary;
- taking relevant technical and organizational measures against inadvertent loss or damage as well as illegal processing of personal data.

7.4. Aunite.io shall not take any actions that might lead aunite.io to violation of the operating Law on Personal Data.

7.5. Aunite.io shall comply with the legislation on protection of personal data.

Depending on the applicable law, Aunite.io shall notify visitors of its website on using the cookie files, including those ones placed by aunite.io (so called third-party cookie). Aunite.io shall explain users the fact and purposes of installation of the cookie files, including the explanation, why this information is collected. Besides, any users must provide a conscious, unambiguous and revocable consent to send the information via these cookie files, that is given prior to the installation of the cookies files in their browsers. The consent shall also apply to the cookie files being installed after a certain action (such as click) is made.
